



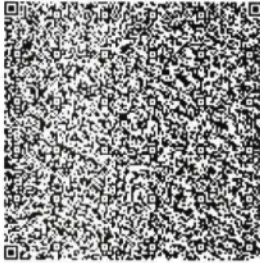

Memorandum of Understanding

This Memorandum of Understanding (MOU) is entered into this day of 1st June 2018 by and between:

Rajni Nijhawan Charitable Trust , having its Registered Office at 2nd Floor, 207, A,J,C. Bose Road, Kolkata – 700017

(hereinafter called 'the Trust ', which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include, its successors and permitted assigns) represented by its Authorized Signatory- Mr. Ian Howard



AND

VAANI Deaf Children's Foundation, having its Registered Office at Flat .2, Shree Apartment, 4G Tiljala Road, Kolkata – 700046, (hereinafter called the 'The Implementing Agency', which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include, its successors and permitted assigns), represented by its Authorized Signatory-Ms.Sumedha Joglekar – Director VAANI Deaf Children's Foundation

Whereas, the Implementing Agency, has submitted to the Foundation a project proposal for Project" **Sadhan** "

Project "Sadhan"- A project proposal for empowering deaf children and their families in Siliguri .

Project Area: Dabgram, Siliguri, North Bengal District, West Bengal

Total Amount For Renewal: INR **5,60,600**(Five Lakh Sixty Thousand and Six Hundred Only) which included 10% increase in the salaries of the Teachers, Community Mobilizer & Project Coordinator)

AND WHEREAS, the Trust having considered the proposal, has agreed to support the above-mentioned Project Sadhan -subject to the following terms and conditions:

NOW THIS MOU WITNESSTH AS UNDER:

1. This MOU shall be valid for a period, 1st June 2018– 31th May2019. However, this MOU shall be renewed for further periods on the same terms and conditions or on a mutually agreed terms and conditions between the parties.
2. The Trust agrees to contribute, a sum of **INR 5,60,600(Five Lakh Sixty Thousand and Six Hundred Only)** to the Implementing agency. The amount will be disbursed in three installments as per the Budget approved by the Trust for a period of one year (1st June 2018 – 31st May2019) as per the following details (refer annexure 2 for detailed budget)
1. The **Annexure-I** which contains the proposal from 'the Implementing Agency' is an integral part of this MOU. In case of any contradiction between the Annexure and the main text of the MOU, the provision of the MOU shall prevail.
2. The Implementing Agency will also submit a **Quarterly Utilization Certificate** as per details in **Annexure-I**, giving details about the expenditure in every quarter.
